

Gas Servicing

About this Course

This course meets Energy Safety requirements in Western Australia. This unit of competence specifies the outcomes required to diagnose and repair faults on domestic and commercial Type A gas appliances. Work associated with this unit is undertaken within the scope of AS5601:2013 gas installations and local licensing requirements (gas, electrical and plumbing)

Pre Requisites

- Must be a qualified plumber
- Must have a USI Number (www.usi.gov.au)
- Restricted G Class Gas Permit issued from Energy Safety endorsed with "Servicing of NG & LPG while working under supervision". (This will require you to contact Energy Safety to arrange an update of your permit with the attached application form) - To be eligible to attend the course,
